## Child Care Grants Comparison Chart

### Hiring and Retention Bonus Grant

*Reopened for new hires April 11 – May 6, 2022*

### NJ ARP Stabilization Grant

*Applications accepted through April 30, 2022  
Application reopens for new providers June 6 – July 3*

#### Who is Eligible

- Licensed child care center staff
- Registered family child care providers

- Licensed child care centers
- Registered family child care providers

#### Grant Amounts

- \$1,000 per eligible staff for licensed child care centers
- \$1,000 per eligible registered family child care providers

Payments will be made in two installments with award amounts based on license capacity, provider type and estimated monthly expenses.

- \$30,000 to \$120,000 for licensed child care centers
- \$4,000 for registered family child care providers

#### How Funds Can be Used

Funds must be used to recruit new staff into the child care workforce.

Funds may be used for wages and benefits, insurance, rent, mortgage, utilities, cleaning and sanitizing, professional development related to health and safety, mental health services, and other operational expenses to remain open and operating. Funds may be used for either past (September 2021) or planned purchases or expenses.

- Federal American Rescue Plan (ARP)
- New Jersey Revitalization Fund

#### General Grant Requirements

- Staff did not receive the initial \$1,000 bonus.
- Staff income \$50,000 or less a year.
- Staff must be in teaching or supervision role.
- Staff must comply with Child Care Development Block Grant trainings.
- Staff must complete comprehensive criminal background checks.
- Programs must be in good standing with state and local health and safety regulations.
- Program must be open and operating.

- Staff must comply with Child Care Development Block Grant trainings.
- Staff must complete comprehensive criminal background checks.
- Programs must be in good standing with state and local health and safety regulations.
- Initial grant, closing April 30, is for programs open and operating as of March 11, 2021.
- New provider application (providers that opened and started operating after March 11, 2021) will be available June 6. New providers cannot apply if they are temporarily closed.

#### Grant Process

- Provider verifies and approves staff information pulled into online application in NJCCIS.
- Grant money is awarded to the provider who is responsible for directly issuing funds to their staff.
- Hiring grants available through May 6, 2022 for newly hired staff or for staff who have not yet received a \$1,000 grant.
- A second phase of the Hiring and Retention Bonus Grant will be available Fall/Winter 2022.

- Provider completes online application and uploads required banking documents in NJCCIS.
- All receipts/invoices for items or services purchased with grant funds must be kept on record, but are not required to be submitted at time of application.
- Providers will be required to complete a recertification to receive the second payment.

#### Payment Process

- Direct deposit within 30 days of application approval.

- The first payment will be made by direct deposit within 30 days of application approval. The second payment will be made in 12 months through a recertification process.
- Licensed child care providers who are open and operating will receive 2/3 of the grant total in their first payment.
- Temporarily closed applicants, who plan to reopen within 60 days of application, will receive 1/3 of the grant total in their first payment (does not apply to new providers).
- Family child care providers will receive two payments of \$2,000.
